Authorized Moneylenders in Tonga

As required by section 3(1) of the Moneylenders Act 2018, the authority to conduct moneylending business in Tonga is restricted only to Authorized Persons licensed by the National Reserve Bank of Tonga. Members of the public are hereby advised that the following entities are Authorized Persons licensed to deal in moneylending business under the Moneylenders Act 2018 as of 29th July 2021:

The National Reserve Bank of Tonga would like to **REMIND** any person or businesses who are conducting moneylending business without a licence to contact the National Reserve Bank of Tonga immediately for the **licensing procedures** and to be **licensed by the National Reserve Bank of Tonga as soon as possible**.

Members of the public are encouraged to report to the National Reserve Bank of Tonga any person or business that is advertising or providing moneylending business services without a valid license or not included in the list above. Any person or business who conduct moneylending **without a valid license** commits an offence and is liable upon conviction to a fine not exceeding \$10,000 or to imprisonment for a term not exceeding three years or both.
